

# FYI Withholding 9 Revenue Online DR 0021W Withholding Attachment Specifications

## GENERAL INFORMATION

Any producer, working, royalty or other interest owner of oil and gas produced in Colorado is required to pay severance tax. Every producer or first purchaser is required to withhold 1% of the gross income paid to every owner and to supply an Oil and Gas Withholding Statement (DR 0021W) by March 1 of each year. The Colorado Reconciliation of Oil and Gas Severance Withholding (DR 0456) is due to the Department of Revenue by April 15.

# USING REVENUE ONLINE

# Register to be a Withholding Submitter

Revenue Online registration is required of anyone who submits DR 0021W forms.

If you have previously registered to submit W2, W2G or 1099's, you will not need to register again. To register, go to Revenue Online (<u>www.Colorado.gov/RevenueOnline</u>) at least five business days before you file your DR 0021W.

- 1. Click on the link Request Withholding Submitter Access.
- 2. Click on Continue.
- 3. Click on the Start Here button to begin.
- 4. Complete the required fields. When finished, click on OK.
- 5. Mark the Terms and Conditions check-box and click on Submit.

A confirmation message will appear on your screen to verify that the Department of Revenue received the registration request. Save this information because you will need it later in the process. In most cases, the registration process is completed overnight; however, it may take up to five business days to complete.

When you have completed the registration process, you will not need to do it again. Each year when you submit your DR 0021Ws in Revenue Online, you will start at Step 2.

## Step 2: Decide how you will report the year-end withholding statements

After successfully registering as a Revenue Online Withholding Submitter, go to <u>www.Colorado.gov/RevenueOnline</u> and select the appropriate option.

- 1. Select Submit a Manual Withholding File to complete a fill-in DR 0021W form for each recipient; or
- 2. Select Submit a Withholding File Attachment to upload a .txt file using the specifications detailed below

There will be many file type options available. Please be sure to choose **21-W File** as the file type. Form DR 0456 is still required to complete your filing. However, paper DR 0021Ws do not need to be mailed in with the DR 0456.

# DR 0021W FILE ATTACHMENT SPECIFICATIONS

- Must be in a .txt file format
- Each recipient must be entered on their own line
- Must be comma delimited
- Must be in the order outlined below
- Non-numeric fields may not use periods or decimals
- Dashes and hyphens must be omitted from numeric fields
- Special characters may not be used
