

Instructions for Retailers

For a retailer to be eligible to claim the electric bicycle income tax credit and provide the \$450 discount on the purchase of a new qualified electric bicycle, the purchaser must be a Colorado resident who has not previously purchased a new qualified electric bicycle that received the \$450 discount during the same calendar year.

To verify the purchaser is a Colorado resident, the retailer must either:

- collect a signed and completed DR 0514, Qualified Purchaser of an Electric Bicycle Affidavit, from the purchaser, **or**
- collect the information included on the DR 0514, Qualified Purchaser of an Electric Bicycle Affidavit, from the purchaser and input that information into the DR 0514 excel spreadsheet.

If a purchaser completes the Colorado driver license or Colorado identification card box on the form, the retailer must verify that the Colorado driver license or Colorado identification card is not expired.

If a purchaser is unable to provide a current, unexpired Colorado driver license or Colorado identification card, the purchaser must provide the retailer with one of the alternative proof of residency documents listed on either the DR 0514, Qualified Purchaser of an Electric Bicycle Affidavit, or the DR 0514 excel spreadsheet.

The retailer must review the alternative proof of residency document to verify that it is dated within 3 months from the date of the purchase of the new qualified electric bicycle. If the document is older than 3 months from the date of the purchase of the new qualified electric bicycle, the retailer cannot provide the discount to the purchaser or claim the income tax credit for the retail sale. The retailer should ensure that the appropriate box on the form is checked or listed on the excel spreadsheet that corresponds with the document they reviewed. The retailer shall return the document to the purchaser after reviewing it. The retailer does not need to retain a copy of the documentation for their records.

The retailer must submit to the Department of Revenue all DR 0514s, Qualified Purchaser of an Electric Bicycle Affidavits, they have collected from eligible purchasers during a reporting period. A retailer must submit these to the Department of Revenue by attaching one or both of the following to each quarterly report the retailer is required to file in Revenue Online:

- PDF copies of all signed and completed DR 0514s, Qualified Purchaser of an Electric Bicycle Affidavits, **and/or**
- A completed DR 0514 excel spreadsheet.

All documents must be dated within three months from the date of the purchase of a qualified electric bicycle. Computer-generated bill (utility, credit card, doctor, hospital, etc.)

Printed bank statement

Pre-printed pay stub

First-class mail (from a government agency or court)

Current homeowner's, renter's, or motor vehicle insurance policy

Mortgage, lease, or rental contract

Transcript or report card from an accredited school

Motor vehicle registration

USPS Change of Address Form CNL107

DD Form 214

If you are unhoused in Colorado and receiving services from a government agency or nonprofit organization, a dated letter on the organization's letterhead stating your situation may be accepted in place of one of the above documents.
