# **Colorado Fuel Tax Refund Permit Application**

## Information and Instructions

#### **Refund Permit**

Refund applicants must obtain a permit from the Department of Revenue before or at the time the first refund claim is made. All claims and correspondence must bear the refund permit number. A permit number will be canceled if the holder doesn't file claims for a period of 24 months. Claimants are required to notify this office of any changes in the nature of the business or address. Claimants are also required to notify this office and re-apply for a new permit if there is an ownership, name, DBA or FEIN change. Permits are nontransferable.

### **Record Keeping**

You must maintain records of your fuel purchases/usage for three years.

#### If have an IFTA account

If you have IFTA in any jurisdiction, you must indicate that you have IFTA and in what Jurisdiction. IFTA account holders are required to report their Colorado IFTA tax paid gallons on a separate claim form or tab on Revenue Online. A copy of the IFTA return is also required.

### **Refund Claims**

All claims must be made within twelve months after the fuel purchase. Only one claim may be filed for a calendar quarter, (Jan.–March, or July–Sept., etc.)

Refunds are not allowed on claims for less than 20 total gallons (except for Political Subdivisions and Government Entities). The best way to file claims is by using our Revenue Online website. A logon and password will be required.

**Section VI** - complete this section as applicable. A complete list of your equipment that uses fuel is required, regardless if a refund will be claimed for the equipment.
